The Parties recognize each other sufficient legal capacity to enter into this agreement on behalf of the respective entities and

HEREBY ACKNOWLEDGE

THAT the Curriculum established by the University of _____ includes the optional completion of an undergraduate rotating internship in institutions or companies.

THAT both, the University of _____ and the Agencia Pública Empresarial Sanitaria Costa del Sol agree to enter a partnership agreement with the purpose of providing undergraduate training.

In the light of the foregoing, the University of _____ and the Agencia Pública Empresarial Sanitaria Costa del Sol

HEREBY AGREE

ONE.-THAT undergraduate and postgraduate internship programs are addressed at medical students from the University of _____ on their rotating internship period.

TWO.-Interns shall not be entitled to any compensation during his or her internship, which duration shall be established in the corresponding Curriculum.

Student's participation in an internship program shall not imply that an employment or contractual relationship exists between the Parties.

THREE.-The University of _____ will provide Interns with a personal health and accident insurance that covers medical, surgical and hospital treatment.

FOUR.-Interns will be supervised by a faculty mentor and a professional mentor for each specialty. The faculty mentor shall be a professional from the University of _____, whereas the professional mentor/s shall be part of the staff of the Agencia Pública Empresarial Sanitaria Costa del Sol. The faculty and professional mentor/s shall assign tasks and responsibilities to the interns, assist them when necessary, and evaluate their performance during the internship.

FIVE.-Upon completion of the internship period, the University of _____ shall provide the corresponding certificates to the Company mentors that have supervised the Intern. On its part, the Agencia Pública Empresarial Sanitaria Costa del Sol shall provide a medical internship certificate to the Intern.

SIX.-The fact that the Agencia Pública Empresarial Sanitaria Costa del Sol enters into this Agreement does not imply that any further liabilities exist, apart from those provided for herein, and in no case involves that the intern is entitled to any employment compensation or benefit.

SEVEN.-Candidates shall be selected by the University of _____ according to the selection criteria established by the University.

EIGHT.-This Agreement shall be in force for a calendar year; thereafter, it will be tacitly extended, unless either Party gives at least 90 days written notice of termination.

NINE.-It is hereby stated that this is an unpaid internship and, consequently, the Intern shall not be entitled to any wages. This Agreement does not imply that an employment relationship exists or will exist between the Parties.

TEN.-It is hereby stated that the Agencia Pública Empresarial Sanitaria Costa del Sol shall not provide any health insurance to the Intern, since no employment relationship exists between this entity and the Intern. Hence, the Intern shall be required to obtain the appropriate health insurance policy prior to commencing the internship in the Agencia Pública Empresarial Sanitaria Costa del Sol. The Intern shall be required to present a copy of his or her health insurance policy prior to initiating the rotating internship in the Hospital.

ELEVEN.-It is hereby stated that the Agencia Pública Empresarial Sanitaria Costa del Sol shall not pay for the Intern's board and lodging costs during the internship period.

TWELVE.- The Intern will be liable for any break, loss, damage or negligence affecting property owned by the Agencia Pública Empresarial Sanitaria Costa del Sol.
